*"Multiple defendants or charges in criminal cases, including traffic cases, all defendants shall be assigned separate case numbers.*

*Where a defendant is charged with a misdemeanor and traffic offense, the defendant shall be assigned one case number. The category selected for the case number and its case type designator shall be that of the offense having the greatest potential penalty."*

## **PROBATION DEPARTMENT 2007**

**In the year 2007, an additional 2096 cases were assigned to probation for supervision. The Department completed 94 pre-sentence investigation reports; and 177 new cases were referred for supervision in the Court Diversion Program. In addition, the department supervised 70 defendants as a condition of their bond.**

**The probation officers maintain regular contact with the probationers in order to ensure that they remain in compliance with the court ordered conditions. During the year 2007, community work service continued to be used extensively by Judge Michael A. Cicconetti. Last year 603 defendants completed 9269 hours in the Court Community Work Service Program. The defendants are required to work at various non-for-profit organizations and at the local municipalities.**

**During 2007, a substantial number of the referrals to the Probation Department were for operating a vehicle under the influence (OVI), driving under suspension (DUS), and domestic violence. It is the responsibility of the probation officer to assess each case that is referred to the Probation Department, and make an appropriate referral to a treatment facility. Domestic violence cases are supervised on an intensive level of supervision.**

**The Painesville Municipal Court Garden Project was once again in operation during 2007 at 3740 Center Rd. in Perry Township, directly behind the township offices. Approximately one acre of land was sowed, tended, and harvested by non-violent offenders as an alternative to their jail sentence. The local nurseries donated these plants, and the harvested vegetables were donated to local charitable organizations such as the Salvation Army, Forbes House, Painesville Senior Center, St. James, and other agencies in Lake County.**

**The Court continued to assess probation fees for defendants that are placed on probation at the rate of \$15.00 per month, unless otherwise stated by court journal entry. Last year \$128,593.77 was collected. The money is used for probation services such as drug testing, domestic violence treatment, staff training, and equipment. In addition, the part-time probation officers and probation secretary are paid from this fund.**

**During 2007, the court continued to use Electronic Monitoring House Arrest (EMHA), and the Interlock System, which does not allow a vehicle to start if alcohol is consumed. These programs were used for repeat OVI offenders and other high-risk clients. Last year 68 defendants served 1849 days on EMHA as a condition of their sentence. The court continued to use the Jail Diversion Program (state funded), which is an extension of the EMHA; however the defendants are not required to pay for the house arrest. In the year 2007, 43 defendants served 1964 days in the Jail Diversion Program, and 28 defendants served 1280 days on EMHA**

as a condition of their bond. In 2007, 5093 days were served under the various EMHA programs.

The Probation Department is responsible for investigating all post-conviction motions that are filed with the court. Over 600 motions are filed on an annual basis requesting some form of modification to their sentence.

Under the supervision of Judge Cicconetti, the Probation Department continued to be active with various professional organizations. The court is represented on the Local corrections Planning Board by Judge Cicconetti and Probation Officer Ivonne Brickell. In June of 2007, the Probation Officers attended the annual training conference in Columbus Ohio, which is sponsored by the Ohio Chief Probation Officers Association. The Probation Department Supervisor attended the American Probation and Parole Summer Institute, which was held in Philadelphia Pennsylvania. This 3-day seminar focused on the current issues and trends in the field of community corrections.

The Painesville Municipal Court Probation Department will continue to provide the most efficient and the highest quality of service while protecting the community by monitoring the offenders that are placed on probation.
